Working through our member organizations, FPSB creates internationally relevant, professional standards for financial planning practitioners so that:

- the public can identify qualified financial planners;
- practitioners can distinguish themselves as trusted financial planning professionals; and
- consumers and regulators can have confidence in the financial planning profession and recognize the benefits that financial planning offers.

FPSB's certification standards demonstrate to those accessing the services of a CERTIFIED FINANCIAL PLANNER professional that the financial planner has met rigorous competency, ethics and professional practice standards to provide financial planning to clients.

To administer the CERTIFIED FINANCIAL PLANNER certification program in a territory, FPSB enters into a licensing and affiliation agreement with the preeminent nonprofit financial planning standards-setting or professional body. By meeting and maintaining FPSB's affiliation requirements and standards, FPSB Member organizations are authorized to administer the CFP certification program in a territory on behalf of FPSB.

FPSB's enforcement of its certification standards through a network of 23 member organizations, and a public-interest mission, has established the CFP Marks as the global symbol of excellence for financial planning.

Financial planning is the process of developing strategies to help people manage their financial affairs to meet life goals. Everyone can benefit from using the financial planning process to understand his or her current financial situation and develop a plan for the future.

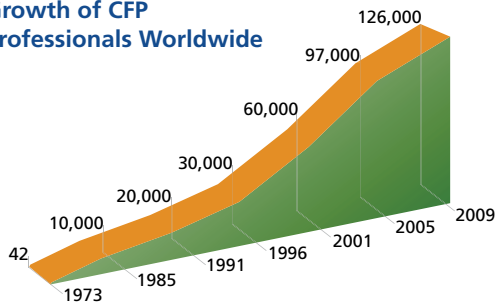

CFP certification is the only globally recognized mark of professionalism for financial planners. To obtain CFP certification, individuals meet initial certification requirements adapted to local marketplaces by FPSB Member organizations.

CERTIFIED FINANCIAL PLANNER professionals demonstrate and maintain competency throughout their careers while:

- providing financial planning in the best interest of clients;
- advising clients and presenting recommendations across a broad range of financial disciplines;
- making professional judgments in ambiguous or complex situations; and
- acting ethically and professionally in their dealings with clients, potential clients, peers and others.
